I hereby acknowledge and understand that unless specifically advised otherwise, the District is not providing transportation, and it is my responsibility to arrange for my transportation to and from the field trip/excursion. If the District is providing transportation but I do not use the transportation, I am responsible to make my own arrangements and the college assumes no liability of any kind for any harm that may arise to myself or to others from the transportation arrangements I make or the transportation I provide.

If the District is not providing transportation I further understand:

- The driver of the vehicle in which I am riding, either as a driver or passenger, is not driving on behalf of or as an agent of the District, and the District has not verified the driving record of the driver, the liability insurance on the vehicle, or the condition of the vehicle.
- The District is in no way responsible, nor does the District assume liability, for any injury or loss which may result from my transportation.
- Although the District may assist in coordinating the transportation and/or recommend travel time, routes, car pooling, or caravanning, recommendation(s) or travel assistance provided by the District is not mandatory and the District assumes no liability for any injury or loss that may result from such recommendations or assistance.

**Release and Indemnity Agreement:** For and in consideration of participating in the field trip/excursion listed above, the undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions or causes of action against the Marin Community College District, its officers, employees, agents and volunteers (herein collectively referred to as "District") from all liability. Such liability includes personal injury, property damage or wrongful death occurring to the undersigned arising out of, in connection with, or as a result of the field trip/excursion, including engaging or receiving instructions in any field trip/excursions activity or any activities incidental thereto wherever or however the same may occur. This release is in effect for the undersigned, his/her heirs, executors, administrators and assigns. The undersigned hereby releases, waives, discharges and relinquishes any action or causes of action, aforesaid, which may hereinafter arise for him/herself, and for his/her estate. The undersigned agrees that under no circumstances will he/she or his/her heirs, executors, administrators and assigns prosecute or present any claim for personal injury, property damage or wrongful death against Marin Community College District or any of its officers, employees, agents or volunteers for any said causes of action, whether the same shall arise by the negligence of any said persons or otherwise.

**It is the intention of the undersigned, by this instrument, to exempt and relieve Marin Community College District from liability for personal injury, property damage or wrongful death caused by negligence or otherwise.**

The undersigned, for him/herself, his/her heirs, executors, administrators or assigns, agrees that in the event any claim for personal injury, property damage or wrongful death shall be prosecuted against Marin Community College District in connection with the field trip/excursion, he/she shall indemnify and hold harmless the Marin Community College District from any and all claims or causes of action by whomever or wherever made or presented for personal injuries, property damage or wrongful death.

The undersigned acknowledges that he/she has read the foregoing Field Trip/Excursion Form and Waiver/Release Notice in its entirety, is fully aware of the legal consequences of signing this release and indemnity agreement, and has signed voluntarily.
